

Corporate Overview

Who we are

The First Nations Capital and Infrastructure Agency of Saskatchewan (FNCIAS) is an Indigenous-led non-profit organization that supports First Nations in Saskatchewan in planning, procuring, owning, and managing on-reserve housing and infrastructure initiatives. We are working with our members to create a service delivery and funding model that leads to sustainable, quality housing and infrastructure in First Nations.

What we do

In the new model, FNCIAS will be the funding and service delivery agency for capital projects, housing, operations, and maintenance programs for its members, funded by Treasury based on a new 10-year renewable agreement. Housing and infrastructure services will continue to be delivered by First Nations, Tribal Councils, and service providers.

FNCIAS will act as an advocacy and support agency that will provide a new framework for delivering Operations and Maintenance Budgets and a Major Capital Program. Funding will be delivered in a single revenue stream to our member Nations with a 10-year funding agreement. Our services are and will be designed and driven by a focus on the responsibility of delivering funding and providing appropriate supports to our member Nations.



2022-2023 Highlights

Funding Gap Analysis and Pilot Assessments in progress

Last Fall, we began conducting a Funding Gap Analysis to support the provision of adequate housing and infrastructure for our member First Nations. As a part of this work, we began conducting Asset Condition Assessment (ACA) and Housing Condition Assessment (HCA) pilots with Pasqua First Nation and Little Black Bear First Nation.

FNCIAS hosts second annual fall conference

On September 19th, 2023, we held our second annual FNCIAS Fall Conference in Saskatoon. We welcomed over 110 in-person attendees, with additional guests tuning in via livestream. The event saw representation from 33 First Nations and two Tribal Councils from across Saskatchewan.

Ongoing engagement and feedback on program and funding delivery model

In 2023, over 50 presentations were given to Saskatchewan First Nations Leadership, Tribal Councils, and First Nations technical staff on the transformation opportunity as well as FNCIAS's Institutional Development Plan. As a result of the engagements, two Nations signed on as members.

Internal capacity building and institutional development

We have continued developing the organization, executing the direction set forth for the organization in our Institutional Development Plan. Several new team members have been added including those with expertise and experience with First Nations in the areas of housing assessments, asset management, and community engagement. The creation and implementation of corporate policies are underway with many policies drafted and in review for implementation in early 2024.

Increased communications channels and infrastructure

We have expanded our communication channels to update and engage with members and other stakeholders as we continue to develop the organization. This expansion includes additional social media channels and an email newsletter platform.

Membership

We are working with First Nations who choose to opt in as members to create a service and funding delivery model. Any Saskatchewan First Nation can become a member of FNCIAS by passing a Band Council Resolution (BCR) to join the program development. The first BCR officially signs a Nation or Tribal Council on as an FNCIAS member and authorizes ISC to release data to FNCIAS. This data helps to inform the funding gap analysis along with the HCAs and ACAs conducted with member Nations. FNCIAS and FNCIAS members are exploring the opportunity of the transfer of federal authorities including responsibility for design and delivery of programs and services. First Nations will then decide whether they want to provide approval for transfer. First Nations that choose to not opt in will continue status quo and operate within the traditional model directly with ISC.


The Road Map & Engagement Process

The road map is a multi-phased planning and transition process where member Nations and Tribal Councils will have the opportunity to inform the process at several decision points along the way. Throughout the 2023-2026 period, our focus is on developing the agency, creating awareness, engaging with members and stakeholders, signing on members, conducting the pilots, and conducting a Funding Gap Analysis.

In 2022-2023, road map progress consisted of engaging with First Nations and Tribal Councils to collect ongoing feedback to help us further refine our focus on the delivery model and the terms of the associated transfer agreement with Canada as well as signing on additional members interested in providing feedback. Our team also began working with members on the asset condition and housing condition assessment pilot to begin quantifying the infrastructure gap on First Nations.

Over the next year our focus will be centred on:

- expanding our pilot assessment to six member Nations
- continuing engaging with members as well as sign on new members
- recruiting and working with the technical and working advisory groups to inform our programs and delivery model

Financial Report

FNCIAS completed our third audit for the year ending March 31, 2023, and has secured direct funding from the government to continue our agency development on our journey to full autonomous operation.

The audited statements are reflective of our organization's third year of stand-alone operations as we increased our staff, secured and renovated office space, and acquired equipment. FNCIAS continues to be well within budget to obtain our objectives within the time periods set out.



Communications and Outreach

Throughout the year, the communications, engagement, and operations teams worked closely to develop materials for presentations about membership and the organization's progress for current and prospective member Nations. The team continues to enhance the website with pages focusing on employment and procurement opportunities. Over the next year, the team will continue to add more features to the website so that members can access more information and resources.
